Project Location/City/County: The project is in and adjacent to the low-flow channel (LFC) of the Feather River, approximately 1.6 miles upstream of the Thermalito Afterbay Outlet, southwest of the town of Oroville, in Butte County.

Project Description: Approval of Permit No. 19718, under California Code of Regulations, Title 23, Article 3, Section 6, for work within an adopted plan of flood control: To install approximately 56 20-foot long by three-foot wide Alaskanstyle resistance board weir panels with 17 10-foot wide substrate rails anchored to the streambed, fish trap, Passive Integrated Transponder antenna array, camera system, and warning signs. All systems will be powered by a fenced solar panel array and appurtenances that will be installed onsite.
