The project will consist of replacing approximately 200 feet of 6-inch diameter polyvinyl chloride (PVC) or verified clay pipe (VCP) sewerline, and the lining of 1,320 feet of existing 6-inch or 8-inch diameter of cured in place pipe (CIPP) sewerline. The project also consists of the replacement of laterals, and cleanouts and boxes; manholes; and appurtenances
		There will be a total of forty-three (43) laterals and one hundred thirteen (113) cleanouts and boxes replaced on Gina Avenue, Dracaea Avenue, Brill Road, Nolze Place, Sherman Avenue, Grant Street, Phyllis Avenue, Farragut Avenue, Ella Avenue, Bertie Avenue, Sierra Mesa Circle,

and Elsworth Street.
The project also includes sewer bypassing, trenching, and backfilling, traffic control, surface restoration, sidewalk, curb and gutter, paving. and street restoration.
Beneficiaries of the project are Edgemont Community Service District customers, which include residential and commercial uses.




Figure 1- Vicinity Map and Project Location ECSD Priority II Sewer Mainline and Lateral Replacement
