Description of Project: The Sonoma County Junior College District has received grant funding from the U.S. Economic Development Administration's disaster relief fund to construct a project that will train construction and trades workers annually to support continued County-wide recovery and rebuild efforts after past regional wildfires. The Project includes a new Construction Training Center within the existing grounds of the District's Petaluma Campus at 680 Sonoma Mountain Parkway, Petaluma, California. The District will utilize the new facility to offer short-term career skill training classes leading to both non-credit certificates and credit programs.

The Project will be located on an approximately 1-acre portion of the overall 40-acre Petaluma Campus. The Project area is located on the northeast side of the Campus and is currently developed as a portion of Parking Lot 3. Within the Project area, existing paving, wheel stops, curbing, light poles, light standards, bollards, and ornamental trees will be removed, and a fire hydrant would be relocated. The Construction Training Center will be an approximately 11,000 gsf single-story building. The building will include two classroom/vocational areas, two laboratories, a covered outdoor work area, faculty office space, storage space, restrooms, and small support space. The new building will also tie into existing utilities located within the Petaluma Campus, including electrical, water, fire water, wastewater, and natural gas. New landscaping and irrigation systems will be installed, including trees, shrubs, cactus, grasses, bioswale plantings, perennials, and ground covers. Additional Project improvements include new walkways, new parking spaces, drive aisles, fire hydrants, trash enclosures, curbs, bike racks, fencing, pedestrian gates, landscape walls, concrete sign wall, and crosswalk striping.
