11. Have California Native American tribes traditionally and culturally affiliated with the project area requested consultation pursuant to Public Resources Code section 21080.3.1? If so, is there a plan for consultation that includes, for example, the determination of significance of impacts to tribal cultural resources, procedures regarding confidentiality, etc.?

Per Assembly Bill 52 (AB52), participating California Native American Tribes were notified of the project and given the opportunity to enter into consultation with the County regarding the proposal.

On January 11, 2022, the following tribes were notified of the proposed project: Picayune Rancheria of the Chukchansi Indians, Dumna Wo Wah Tribal Government, Table Mountain Rancheria, Santa Rosa Rancheria Tachi Yokut Tribe. Of the notified tribe Table Mountain Rancheria responded with a letter indicating interest in the project and requesting consultation. A records search conducted by the Southern San Joaquin Valley Information Center was provided to Table Mountain Rancheria (TMR) representatives, followed by an onsite visit on May 18, 2022. Following the onsite visit, it was determined that no cultural resources were present or at risk of being disturbed by the proposed project. TMR representatives indicated via an email to the County on May 23, 2022, that the consultation was completed pursuant to AB52.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code section 21080.3.2.) Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation. Please also note that Public Resources Code section 21082.3(c) contains provisions specific to confidentiality.
