City of Isleton – Notice of Intent to Adopt a Mitigated Negative Declaration

Notice is hereby given that the City of Isleton has tentatively determined that the project described below will not result in a significant adverse impact on the environment and that, in accordance with the California Environmental Quality Act, the City is prepared to issue a "mitigated negative declaration" in accordance with the California Environmental Quality Act:

Project Description: Tentative Subdivision Map to subdivide a 1.13 acre vacant property into seven (7) single family residential lots (Figure 1). The proposed Tentative Map will split the parcel into 7 lots: Lot 1 (7,143 SF), Lot 2 (7,000 SF), Lot 3 (7,000 SF), Lot 4 (7,000 SF), Lot 5 (7,000 SF), Lot 6 (7,000 SF), and Lot 7 (7,174 SF). The project site is located in the R-1-7, Single Family Residential Zoning District which allows this level of development. All lots will be accessed by existing public right of ways. Lots 1, 2, and 3 will be accessed via D Street. Lots 4 and 5 will be accessed via 6th Street. Lots 6 and 7 will be accessed via Gas Well Road. City water and sewer area available to the property.

Project Location property is located on 6th Street at the corner of D Street and Gas Well Road, APN 157-0040-053.

This tentative determination to find that the project will not result in a significant adverse environmental effect is based on an environmental study that assesses the project's potential environmental impacts. The environmental study includes a list of 14 mitigation measures that have been incorporated into the project that reduces the project's potential adverse impacts to a level of non-significance.
