# Project Description

The California Department of Transportation proposes an emergency roadway project to correct failed pavement on northbound Interstate-5 at post miles 49.0/49.3 in San Joaquin County. Lane two has settled approximately 4-inches due to base failure underneath the concrete panels. The entire structural section of the damaged lane will be removed and replaced. The adjacent shoulder will also be replaced with hot mix asphalt. The purpose of the project is to correct the collapsing pavement section of the highway. The differential settlement between the two lanes poses a potential hazard to the traveling public.
