DESCRIPTION OF NATURE, PURPOSE AND BENEFICIARIES OF THE PROJECT:

The proposed project is a Use Permit to allow the parking and operation of a Food Truck with an outdoor dining area on a 2.55-acre parcel. The site is partially developed with a Gas Station, appurtenant convenience store, and paved parking area with 14 shared spaces.
