Brief Description of the Project: Agricultural Erosion Control Plan (#P21-00064-ECPA) involving the clearing of vegetation, earthmoving, and installation and maintenance of erosion control measures associated with the development of approximately 4.3 gross acres of vineyard (i.e., development area or proposed clearing limits) with approximately 3.0 net planted acres, within two vineyard blocks located on an approximately 28.17-acre property.
