DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: The purpose of this project is to implement phased treatment of nonnative, invasive trees in the natural areas around campgrounds and historic landscapes of Angel Island State Park to reduce fuel loads, improve biodiversity, and protect native grassland and coastal plant communities.

Project efforts will occur in the South-West side, Eastside, and Northside Management Units (MU) in previously managed areas and new areas. Species targeted for removal include Monterey Pine, Acacia, Monterey Cyprus, Eucalyptus, Mayten tree, and Tree Tobacco. Work will include manual/mechanical cutting of trees, with cut material piled for future burning, chipped, or incinerated in an air curtain burner or lopped and scattered depending on the area. Herbicide may be used to control some trees prone to resprout, including Acacias, Eucalyptus, Mayten tree, and Tree Tobacco and will be applied via spray bottle, backpack sprayer, paint brush, or injection device in a manner consistent with Integrated Pest Management policies and License Pest Control Advisor Recommendations encompassing all applicable laws and regulations.
