Description of Nature, Purpose and Beneficiaries of Project:

The project will develop high power discharge capabilities for a battery-electric agricultural tractor, deploy and integrate bidirectional chargers with existing on-farm electrical service points, and manage charging and loads in several grid integration use cases. Bidirectional charging and vehicle grid integration use cases will be tested in a laboratory environment and at two demonstration sites. The project will lead to ratepayer benefits including increased renewable penetration from solar deployed on farms, providing backup power to critical loads, and lowering costs by shifting load.
