F. Reasons why the project is exempt:

- 1. Class 6 Categorical Exemption consists of basic data collection, research, experimental management, and resource evaluation activities which do not result in a serious or major disturbance to an environmental resource. These may be strictly for information gathering purposes, or as part of a study leading to an action which a public agency has not yet approved, adopted, or funded. This project is being done for the purpose of data collection to evaluate and manage an environmental resource by a public agency, and therefore qualifies under this exemption.
- 2. Ministerial Project: Section 21080 of the Public Resources Code exempts from the application of CEQA those projects over which public agencies exercise only ministerial authority. Wells such as these require only a ministerial well permit from the County.
