NOTICE OF A PROPOSED INITIAL STUDY AND MITIGATED NEGATIVE DECLARATION

Project Title: Annexation No. 2022-01 and Victory Oaks Tentative Subdivision Map No. 5586

<u>Project Description</u>: Annexation No. 2022-01 is a request by D.R. Horton, to annex one parcel totaling approximately 23.7 acres into the city limits of Visalia and to detach said parcel from Tulare County Service Area No. 1. The Victory Oaks Tentative Subdivision Map No. 5586 is a request to subdivide the 23.7-acre site into 117 single family residential lots and a 2.02 acre park. The project will include the construction of local streets within the subdivision and connection to West Ferguson Avenue to the south. Frontage street improvements will also be required along with right of way dedications along West Ferguson Avenue. These types of improvements include construction of curb, gutter, sidewalks, and the installation of park strip landscaping and streetlights throughout the subdivision. The subdivision is anticipated to provide vehicular connectivity to an existing subdivision to the north of the subject site.

The development of the property, if approved, will create additional housing units in the northwest portion of the City at a density of 5.09 dwelling units to the gross acre within the Low Density Residential designation area as well as provide a 2.02 acre park; all of which are consistent with the General Plan.

<u>Project Location</u>: The project site is located 800 feet west of the North Demaree Street and West Ferguson Avenue within a county island (APN: 077-190-007).
