WHEREAS, the Yucaipa Valley Water District (the "District") is a public agency of the State of California organized and existing pursuant to the provisions of the County Water District Law of this State (Section 30000, et seq. of the Water Code); and

WHEREAS, the District is responsible for the construction, maintenance and monitoring of water, recycled water and wastewater facilities within the District's service area; and

WHEREAS, the District is upgrading the computer system software used to monitor the equipment at the wastewater treatment plant in order to improve cybersecurity and system networks to ensure safe and reliable monitoring of the community's water supply; and

WHEREAS, it is the goal of the District to provide secure, efficient, and resilient control systems for day-to-day operations in order to provide environmentally sound, reliable and safe water, wastewater collection systems, recycled water distribution systems, and water purification systems.

- 1. The Board of Directors hereby finds that approval of the Project is not subject to environmental review under the California Environmental Quality Act (CEQA), Public Resources Code §21000 et seq. and the State CEQA Guidelines, California. Article 5, 15062 Notice of Exemption.
- 2. The installation of the Supervisory Control and Data Acquisition at the Henry Wochholz Regional Water Recycling Facility is classified under Class 1(b), §15301 Existing Facilities.
- 3. The Board of Directors hereby approves the installation of the Supervisory Control and Data Acquisition upgrade and directs the General Manager to file the Notice of Exemption with San Bernardino County and the Office of Planning and Research.
