Additionally, NOTICE IS HEREBY GIVEN that the Fort Bragg Planning Commission will conduct a public hearing to consider approval of the project and the proposed IS/MND at the regularly scheduled meeting on Wednesday, October 12, 2022, at 6:00 PM or as soon thereafter as the matter may be heard at Town Hall, at the corner of Main and Laurel Streets (363 North Main Street), Fort Bragg, California. **The Public Hearing** will be opened for public participation on October 12, 2022 at 6:00 p.m., or as soon thereafter as the matter may be heard. All interested persons are invited to appear at that time to present their comments. The public comment period runs from the date this notice is published until the date of the hearing to allow sufficient time for submission of comments by mail. Public Comment regarding this Public Hearing may be made in any of the following ways: (1) Written comments may be emailed to the Community Development Department at <u>CDD@fortbragg.com</u>, or delivered to City Hall, at 416 N. Franklin Street, before 3:00 PM on the day of the meeting. (2) Verbal comments made during the meeting, either in person at Town Hall or virtually using Zoom if a Zoom link is provided at the time of agenda publication.

At the conclusion of the public hearing, the Planning Commission will consider a decision on the above matter.

**Appeal process and fee schedule:** Decisions of the Planning Commission shall be final unless appealed to the City Council in writing within ten (10) days thereafter with a filing fee of \$1,000 to be filed with the City Clerk. If you challenge the above case in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice or in written correspondence delivered to the Community Development Department at, or prior to, the public hearing.
