Description of Nature, Purpose, and Beneficiaries of Project:

The primary objectives of the proposed Project are to create juvenile salmonid rearing habitat during low flow conditions of the Sacramento River; reduce fish stranding pools; and increase the availability of adult spawning habitat in the river. The Project consists of constructing a river side channel along the west bank of the Sacramento River with an inlet and outlet connected to the river. Suitable gravel obtained from channel excavation will be sorted onsite and placed in the Sacramento River to provide spawning habitat for adult salmonids. Activities include excavating a linear side channel designed to remain inundated during low flow conditions, repurposing removed woody debris from excavation for in-stream habitat features for fish within the side channel, and seeding disturbed areas with native plant species to mitigate for temporary and permanent impacts. Natural resource impacts include the removal of understory trees, unearthed material in channel excavation and bank stabilization, and the remnants of spoil piles.

Exempt Status:

The California Regional Water Quality Control Board, Central Valley Region has determined that the Project is exempt from review under CEQA pursuant to California Code of Regulations, title 14, section 15333, Small Habitat Restoration Projects. Class 33 consists of projects not to exceed five acres in size to assure the maintenance, restoration, enhancement, or protection of habitat for fish, plants, or wildlife provided that (a) there would be no significant adverse impact on endangered, rare or threatened species or their habitat pursuant to section 15065; (b) there are no hazardous materials at or around the project site that may be disturbed or removed; and (c) the project will not result in impacts that are significant when viewed in connection with the effects of past projects, the effects of other current projects, and the effects of probable future projects.

Reasons why Project is Exempt:

This project is Categorically Exempt under CEQA section 15333 because the project's sole purpose is salmonid habitat restoration and is less than 5 acres in size.
