A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERBANK, CALIFORNIA ADOPTING THE MITIGATED NEGATIVE DECLARATION AND MITIGATION MONITORING AND REPORTING PROGRAM FOR THE RIVERBANK REGIONAL RECYCLED WATER PROJECT AND APPROVING THE PROJECT

THE CITY OF RIVERBANK CITY COUNCIL (HEREAFTER REFERRED TO AS THE "CITY COUNCIL") DOES HEREBY RESOLVE THAT:

WHEREAS, the City of Riverbank (City) is the lead agency for the Riverbank Regional Recycled Water Project (Project); and

WHEREAS, the Project includes upgrade and expansion of the City of Riverbank's existing wastewater treatment plant to serve planned growth in the City through the year 2050 and produce high quality (disinfected tertiary treated) recycled water for distribution to nearby landowners for irrigation of orchards; and

WHEREAS, in order to comply with the requirements of the California Environmental Quality Act (CEQA), the City has prepared an Initial Study/proposed Mitigated Negative Declaration (IS/MND) that evaluates the environmental effects of the Project; and

WHEREAS, the IS/MND was circulated for public review from September 21, 2022 through October 20, 2022; and

WHEREAS, the IS/MND concluded that significant environmental effects on various resources would be avoided or reduced to less-than-significant levels by mitigation measures identified in the IS/MND; and

WHEREAS, the comments received on the IS/MND, with responses to these comments, are attached hereto as Exhibit B; and

WHEREAS, the IS/MND, attached hereto as Exhibit A, together with the Mitigation Monitoring and Reporting Program (MMRP) attached hereto as Exhibit C, constitute the Final Mitigated Negative Declaration (Final MND); and

WHEREAS, the Riverbank City Council has considered the Final MND together with the comments received, and

The Riverbank City Council hereby finds that the IS/MND was prepared, published, circulated, and considered in accordance with the requirements of the California Environmental Quality Act (CEQA) and the State CEQA Guidelines; constitutes an adequate, accurate, objective, and complete MND in accordance with the requirements of CEQA and the State CEQA Guidelines; and reflects the independent judgment and analysis of the Riverbank City Council.
