**Description of Nature, Purpose, and Beneficiaries of Project:** The Applicant proposes to replace an existing double 84-inch reinforced concrete pipe (RCP) culvert system. The existing culvert system (DS# 57805000784) is failing due to cracks, spalling, exposed reinforcement bar, joint separation, shape deformity, and misalignment. The extent of damage has been deemed significant enough that a District Director's Order (DDO) was assigned to this project from the Applicant. The replacement of this failing culvert system will involve jack and bore methodology to abandon the failed piping, and then replacement and realignment of the culvert system with similar double 84-inch RCP. The construction of the jacking pits will require the removal of 1,250 yd³ of soil to a depth of 15 feet and the removal of 150 linear feet of concrete trapezoidal ditch structure. Following installation of the new culvert system, the jacking pits will be backfilled to the original grade and the concrete trapezoidal ditch will be restored to pre-construction conditions.
