Participating California Native American Tribes were notified of the subject application and given the opportunity to enter into consultation with the County of Fresno on addressing potential tribal cultural resources on the project site. Participating California Native American Tribes did not enter into consultation with the County on the project and no concerns were expressed by reviewing tribal governments.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation. ## INITIAL STUDY ENVIRONMENTAL CHECKLIST FORM
