This notice is to advise responsible and trustee agencies as well as interested parties and those potentially affected by the project that the City of Lancaster has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) for the project identified below (TTM No. 53642/CUP No. 22-08). The City has determined that the project will not result in significant environmental impacts with the implementation of the identified mitigation measures.

Project Description: The proposed project consists of the subdivision of approximately 37 gross acres for the construction and occupancy of 207 single-family residential lots in the R-7,000 (single family residential, minimum lot size 7,000 square feet) zone (TTM No. 53642). The applicant has also submitted a conditional use permit application (CUP No. 22-08) to allow for a residential planned development with smaller lots than the zoning would permit. The minimum lot size would be 4,250 square feet and the development would also provide approximately 5.89 acres of open space including paseos, recreational areas and green belts.

Location: The project site is located at the southeast corner of 60th Street West and Avenue K-4 in the City of Lancaster (Assessor's Parcel Numbers [APNs] 3204-009-026, 3204-009-079, 3204-009-081).

Mitigation Measures: Mitigation measures have been identified for air quality, biological resources, cultural resources, geology and soils, hazards/hazardous materials, and noise.
