As I understand it, this development project would result in the construction and occupancy of 14 single family detached dwellings.

This project is in the attendance boundaries of Chet F. Harritt School. Based on the information you provided and current school capacity analysis, it is estimated that this development would generate seven (7) students. At this time, Chet. F. Harritt School can accommodate these new students, however, the District reserves the right to assign students to schools throughout the Santee School District based on various factors, including, but not limited to, space availability. Please also be aware that Santee School District serves students from Grades Preschool through 8th. Information on availability of high schools (Grades 9 through 12) should be obtained from Grossmont High School District.

The above notwithstanding, this project will require the payment of Developer Fees at the residential per square footage amount that is in effect at the time building permits are to be issued.
