The California Department of Transportation (Caltrans), utilizing State Funds only, is proposing to restore State Route 96 in Siskiyou County from PM 28.0 to 34.5 to a condition that requires minimal maintenance. This Highway Maintenance (HM) dollar job would apply a 0.10' overlay with isolated dig outs over approximately 6.5 miles on State Route 96 in Siskiyou County (PM 28.0/34.5).

Guardrail will be reconstructed and shoulders backed to standard. All work will be done within the existing hinge points. No work will be performed on bridge decks. There will be no increase in disturbed soil area or impervious surface. Removal of thermoplastic pavement markings will be required. This project will be constructed in 2022 and will take approximately 25 working days.

Purpose: The purpose of the project is to provide efficient, easily maintained pavement that provides minimum maintenance for multiple years, as well as increase safety for travelers and workers.

Need: The existing roadway and pavement surface is in a poor condition.

Right-of-Way

Acquisitions or TCEs will not be needed for this project due to work being confined to ROW.

Staging/Stockpiling

Multiple locations are available for staging/stockpiling use. No grading and/or site preparation will occur. Approved staging locations include: PM 28.41 EB, PM 28.56 EB, PM 29.34 EB, PM 29.55 EB, PM 30.13 EB, PM 30.19 EB, PM 30.42 WB, PM 31.29 EB, PM 32.42 EB, PM 32.71 EB, PM 33.07 EB, PM 33.23 EB, PM 33.95 EB, PM 34.67 EB.

Disposal/Borrow Sites

The project would not utilize borrowed material. Excess material will be the property of the contractor.

Utilities

All utilities in proximity to the locations of work would be protected in place; no utility conflicts are anticipated.

Coordination/Consultation

Caltrans has performed an environmental evaluation consisting of a review of resource records and databases, consultation, and coordination with applicable agencies and individuals.
