## **Project Title:**

5000 Patrol Road Lot Line Adjustment

The property is located on the east side of Patrol Road and north of Dean Street in McClellan Park Special Planning Area (SPA) in the North Highlands community of unincorporated Sacramento County.

#### **Exempt Status:**

Categorical Exemption (PRC Section 21084; California Environmental Quality Act (CEQA) Guidelines Sections 15300 -15333):

CEQA Guidelines Section 15305 – Minor Alterations In Land Use Limitations

#### Reasons why project is exempt:

The project is a minor lot line adjustment not resulting in the creation of any new parcel. As such, the project qualifies as a Class 5 categorical exemption (Section 15305 of the CEQA Guidelines)



for minor alterations to land use limitations in areas with an average slope of less than 20 percent, which do not result in any changes in land use or density. For these reasons, there is no possibility that the activity in question may have a significant impact on the environment and is therefore exempt from the provisions of CEQA.

## Section 15300.2 - Exceptions

Section 15300.2 of the CEQA Guidelines, Exceptions, provides conditions under which categorical exemptions are inapplicable. Review of the Project indicates that it will not violate any of the exceptions, as described in the following section.

- The project will occur in certain specified sensitive environments or locations;
   The Project will have no impact on specified sensitive environments or locations.
- 2. Cumulative impacts will be considerable because successive projects of the same type will occur at the same place overtime;
  - The Project will not result in significant singular or cumulative environmental impacts. No cumulative impacts will result from the Project and successive projects of the same type and at the same place over time.
- 3. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstance.
  - There are no unusual circumstances that will result in a significant effect on the environment.
- 4. The project may result in damage to scenic resources, including but not limited to trees, historic buildings, rock outcroppings, or similar resources within a highway officially designated as a scenic highway;
  - The Project is not located in the vicinity of a highway officially designated as a scenic highway. The closest State designated scenic highway is over 10 miles from the project site. Therefore, the project will not result in damage to scenic resources or similar resources within a highway that is officially designated as a scenic highway.
- 5. The project is located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; or
  - The Project site is not included on any list compiled pursuant to Section 65962.5 of the Government Code. Therefore, the Project will not have an impact related to being located on a hazardous waste site.
- 6. The project may cause a substantial adverse change in the significance of a historic resource.

  The project site does not contain any historical resources.
