Project Description: The Division received seventy-nine (79) Notices of Intention to Drill New (NOIs) from the Applicant to conduct well operations on mineral and surface estates administered by the BLM Bakersfield Field Office within the Cymric Oilfield in Kern County. The proposed project would occur on previously disturbed well pads that require minor grading to level the location.

Project implementation would include the grading of existing disturbed locations, the installation of associated pipelines and power poles, and the drilling of seventy-nine new wells.
