Project Title: Former Marchant/Whitney Site Remedial Action Plan

Location of Project: 5679 Horton Street, Emeryville, California

Project Description:

Environmental investigations conducted throughout the 1.75-acre Site have found the presence of cadmium in soil, total petroleum hydrocarbons (TPH) in soil and groundwater, and volatile organic compounds (VOCs), primarily trichloroethene (TCE), in soil, groundwater and soil vapor (air in between soil particles). TCE-impacted groundwater also extends to the west of the Site. The draft FS/RAP proposes a demolition of the existing building, soil excavation with off-site disposal of contaminated soils, soil and groundwater with heat and extraction of soil vapors and groundwater, and if necessary injection of biological additives for cleanup of residual contaminants, conducting a soil vapor assessment to determine if vapor intrusion mitigation systems are warranted to prevent contaminants in soil vapor from entering indoor air in buildings, capping the Site with hardscape, and land use restrictions.

The purpose of the project is to mitigate chemicals of concern (COCs) in soil, soil vapor, and groundwater at the Site. The draft *Updated Feasibility Study/Draft Remedial Action Plan (FS/RAP)* for the project site identified VOCs, the metal cadmium, and hydrocarbons as COCs at the site. In addition, VOC-impacted groundwater has moved offsite toward the southwest to a nearby mixed use residential/commercial property. DTSC will be providing oversight for the implementation of the remedial actions recommended in the FS/RAP.
