PROJECT TITLE: Railtown 1897 Tri-Dam shop EV charging station/Vehicle Gate

LOCATION: Railtown 1897 State Historic Park **COUNTY:** Tuolumne

DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: The purpose of this project is to install a two-vehicle electrical charging station and a vehicle gate at the Tri-Dam Shop located at Railtown 1897 State Historic Park to provide charging for state park electric vehicles and additional security for the area around the Tri-Dam shop. Work will:

- In the Tri-Dam carpenter shop electrical service panel, install two (2) additional correctly sized circuit breakers for 40 amp service;
- Install rigid conduit from the panel to the front of the building and pull 10 gauge wire for power;
- On interior north wall, install an emergency shutoff;
- On the exterior north wall, install a new EV charging unit;
- Construct a 4-ft by 5-ft lean-to roof structure to protect the charging station;
- Install 2-in. square, 14 gauge fence posts set in concrete every 8' at 18" deep, except at the 20 foot sliding gate section; and
- Install a 75-ft long by 5-ft tall, 2-in. square ornamental black powder coated iron vehicle fence with two (2) 5-ft tall by 10 foot manual sliding gates for vehicular access and one (1) 5-ft tall by 4-ft person gate.
