Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 01/18/2018, by GOLDEN GATE GEN INC. The GOLDEN GATE GEN INC. applied for a cannabis distribution license.

Project Activities:

The proposed project will operate a cannabis distribution operation out of an existing facility located at 1560 YOSEMITE AVE, SAN FRANCISCO, CA 94124 (APN 4830-016).

The applicant has proposed to use a 4,000 sq.ft. suite on 2.44 acres lot to operate a cannabis distribution business.

1560 Yosemite Ave (licensed location) is 1 unit in a 20 unit building with the master address if 1590 Yosemite Ave. The main building is cinder block construction with steel studs and drywall walls separating each unit. 1560 Yosemite has it's own man door and roll-up door exiting onto Yosemite Ave. There is no access to 1560 Yosemite from other units.

1560 Yosemite was previously used by the City of San Francisco for storage.

No modifications have been made to the property.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
