DESCRIPTION OF NATURE AND PURPOSE OF THE PROJECT: Conditional Use Permit (CUP), Planned Development Permit (PDP), and a Neighborhood Development Permit (NDP) for the construction of a temporary Wireless ... Community Facility (WCF) during construction of a permanent WCF. The temporary facility would consist of 6 panel antennas measuring 72" x 20" x 7.8", 12 Remote Radio Units (RRUs) on three (3) 64-foot wood poles embedded into the ground. The permanent facility would consist of 12 panel antennas measuring 28" x 15.7" x ...6.7" and 31" x 16" x 9", 9 RRUs inside of a 48' tall faux tower. Additionally, the project includes ancillary equipment for support to the WCF including 2 equipment cabinets for both the temporary and permanent facility. The temporary facility will have a 20' x 20' equipment enclosure. The 215-square foot equipment enclosure is located at the base of the permanent faux tower. The project is located at 14050 Carmel Ridge Road in the RS-1-14 zone, the ALGUP Airport Influence Area – MCAS Miramar, the Carmel Mountain Ranch Community Plan.

REASONS WHY PROJECT IS EXEMPT: The City of San Diego determined that the project would qualify to be categorically exempt from CEQA pursuant to Section 15303 (New Construction). The exemption allows for the construction and location of limited numbers of new, small facilities or structures where only minor modifications are made. Since the project would only construct one WCF on a previously project site that lacks sensitive resources it was determined that the exemption was appropriate, and the exceptions listed in CEQA Section 15300.2 would not apply.


