A PUBLIC HEARING HAS BEEN SCHEDULED BEFORE THE PLANNING COMMISSION OF THE CITY OF FONTANA FOR THE FOLLOWING:

Master Case No. 20-083, Tentative Parcel Map (TPM) No. 20-021 (TPM No. 20464), Conditional Use Permit (CUP) No. 20-025, Conditional Use Permit (CUP) No. 22-018, Conditional Use Permit No. 22-019, Conditional Use Permit (CUP) No. 22-028, Design Review Project (DRP) No. 20-031, and Variance (VAR) No. 22-001

The applicant is proposing a development to construct a multi-tenant commercial development on an 8.8-acre site, composed of a banquet hall, a dual branded hotel (Holiday Inn Express / a Staybridge Suites), a Restaurant, and an In-N-Out Burger. Additionally, a State of California Alcohol Beverage Control (ABC) Licenses type 41 for the Staybridge Hotel, and type 47 for the Banquet Hall, a Tentative Parcel Map to subdivide the property into four (4) parcels, the site and architectural review for the commercial development, and a Variance to reduce the rear yard setback abutting the freeway from 25 feet to 2 feet. The project includes onsite improvements such as decorative landscaping, surface parking, drive thru, security lighting and among other associated improvements.

Environmental Determination:

An Initial Study/Mitigated Negative Declaration (IS/MND) has been prepared for this project in accordance with Section 15072 of the California Environmental Quality Act (CEQA) and Section 6.04 of the 2019 City of Fontana Local Guidelines Implementing the CEQA. Based on the information in the IS/MND, all significant impacts anticipated as a result of project implementation would than with mitigation



incorporated, and a Mitigation Monitoring and Reporting Program (MMRP) has been prepared for the Planning Commission's consideration; therefore, a Notice of Determination has been prepared.
