

### NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION



For County Clerk's Stamp

Notice is hereby given that the County of Fresno has prepared Initial Study Application (IS) No. 8312 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

**NITIAL STUDY NO. 8312** and **AMMENDMENT APPLICAITON NO. 3851** filed by **STEVE BAINS** proposing to rezone the subject 16.89-acre parcel from the AL-20 (Limited Agricultural, 20-acre minimum parcel size) to the R-R (Rural Residential, two-acre minimum parcel size) Zone District, and allow a mapping procedure to create five parcels meeting the minimum parcel size of two acres. The subject parcel is located on the southeast corner of E. Herndon Ave. and N. Highland Ave., approximately 0.8-miles north of the city limits of the City of Clovis. (APN: 308-280-63) (9045 E Herndon Ave.) (Sup. Dist.: 5).

(hereafter, the "Proposed Project")

The County of Fresno has determined that it is appropriate to adopt a Mitigated Negative Declaration for the Proposed Project. The purpose of this Notice is to (1) provide notice of the availability of IS Application No. 8312 and the draft Mitigated Negative Declaration and request written comments thereon; and (2) provide notice of the public hearing regarding the Proposed Project.
