## **Project Description:**

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 11/01/2021, by GREEN RIBBON DISTRIBUTION. The GREEN RIBBON DISTRIBUTION applied for a cannabis distribution-transport only operation.

## **Project Activities:**

The proposed project will operate a distribution-transport only operation out of an existing facility located at 428 C ST, UNIT C, EUREKA, CA 95501(-0350) (APN 001-071-003).

The applicant has proposed to use a 323 gross sq. ft unit on a 13,200 sq. ft. lot to operate a cannabis distribution-transport only business.

## Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing building which was formerly used previously as office space with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
