PROJECT DESCRIPTION

The project site is located on the existing operational Kneeland Helitack Base. The proposed project will consist of demolition of an existing helipad to construct a new larger helipad (75 ft by 75 ft) and installation of lighting. Soil will be displaced to a depth of 18 inches during construction of the foundation for the helipad. The new cement pad will be approximately eight inches thick. Lighting for night operations will be installed requiring minor trenching. No more than one acre will be disturbed during the construction of the helipad. Existing roads will be used and maintained whenever possible. The activities proposed will be located in the existing helipad footprint. No trees will be removed, and no watercourses are affected by this project.
