Description of nature and purpose of the Project: The project proposes a Coastal Development Permit (CDP) to convert an existing 572 square-foot detached garage into an Accessory Dwelling Units (ADU), on a 0.18-acre site. The existing 3,848 square-foot, two-story residence with basement would remain. The project is in the RS-1-7 (Residential Single-Unit) Zone, within the Peninsula Community Plan, Coastal Overlay Zone (Non-Appealable 2), Coastal Height Limit Overlay Zone, Parking Impact Overlay Zone (Coastal Impact), Airport Influence Area (San Diego International Airport (SDIA), Review Area 2), and the Federal Aviation Administration (FAA) Part 77 Notification area (SDIA and North Island Naval Air Station). The community plan designates the site as single family residential (9 dwelling units per acre).

Reasons why project is exempt: The City of San Diego conducted an environmental review that determined the project would not have the potential to cause a significant effect on the environment. The project meets the criteria set forth in CEQA Section 15303 which consists of construction and location of limited numbers of new, small facilities or structures; and the conversion of existing small structures from one use to another where only minor modifications are made in the exterior of the structure. Since CEQA Section 15303 allows for conversion of existing small structures from one use to another where only minor modifications are made to the exterior of the structure, this exemption was deemed appropriate. In addition, the exceptions listed in CEQA Section 15300.2 would not apply.


