The County of San Bernardino, as the lead agency under the California Environmental Quality Act (CEQA), will be coordinating the preparation of an Environmental Impact Report (EIR) for the proposed Pepper 210 Commerce Center Project. The County is requesting identification of environmental issues and information that you or your organization believes should be considered in the EIR.

Project Location: The Project Site is located at 20080 Highland Avenue in unincorporated San Bernardino County (Assessor Parcel Number 0264-431-18).

Background: The Project Site is located at 20080 Highland Avenue in unincorporated San Bernardino County (Assessor Parcel Number 0264-431-18). The Project Site comprises approximately 101 acres and has been used as an aggregate mining and rock crushing facility for approximately 70 years. Upon closure of the aggregate mining and rock crushing facility and completion of reclamation activities, the Project Site would be redeveloped as an industrial commerce center facility.

Project Description: The applicant is proposing a Land Use Category Change (General Plan Amendment) from Resource Land Management (RLM) to General Industrial (GI) and a Zoning District Amendment from Resource Conservation (RC) to Regional Industrial (IR), in conjunction with a Tentative Parcel Map and Conditional Use permit to allow for the placement of a 1,232,660 square-foot warehouse/distribution/logistics building. With consideration of potential mezzanine space for offices and pick modules, the total floor area of the building could be up to 1,867,660 square feet. The Project also provides for the construction of a 2,100 square-foot ancillary yard office building, trailer parking areas, passenger vehicle parking areas, landscaping, exterior lighting, signage, and connections to existing utility infrastructure. The Project Applicant is developing the Project on a speculative basis and no user(s) has/have been identified for the Project; there is potential for the yard office building and one of the on-site trailer parking areas to operate independently of the proposed warehouse/distribution/logistics building. For analysis purposes, the Project is assumed to be operational in the Year 2027 and would operate 24 hours per day, 7 days per week.

Potential Environmental Effects: CEQA Guidelines Section 15063 grants Lead Agencies the ability to bypass preparation of an Initial Study and proceed with preparation of an EIR in instances where an EIR is clearly required for a project. In this instance, San Bernardino County in its capacity as Lead Agency for the proposed Project has determined that the Project clearly has the potential to result in significant environmental effects and that an EIR shall be prepared that addresses the following environmental considerations:

The EIR will evaluate the Project's potential to generate additional traffic in the region, in particular on SR-210. The EIR will also evaluate the Project's potential to result in emissions from construction and operation activities that could affect air quality and climate change and noise from construction and operation activities that could affect nearby sensitive receptors. The EIR will evaluate the Project's potential to affect any species identified as a candidate, sensitive, or special status, riparian habitat or other sensitive natural community, federally protected wetlands, or wildlife movement. The EIR will identify if there are any archaeological, historic, or paleontological resources onsite that could be adversely affected by Project. The potential for the Project to affect the existing drainage patterns of the site or to affect water quality for downstream waters will also be evaluated in the EIR.
