Project Description

The California Department of Transportation (Caltrans) proposes a culvert replacement project at post miles (PM) 22.33 and 22.66 on State Route (SR) 49, Tuolumne County. Location 1 (PM 22.33) includes an existing two-culvert system. The scope of work at Location 1 includes installing an 18" metal Flared End Section (FES) at the outlet of the first existing culvert. For the second existing culvert at Location 1, the scope of work includes replacing the existing concrete headwall at the inlet, replacing the existing 30" Corrugated Steel Pipe (CSP) with a 36" Reinforced Concrete Pipe (RCP) and rubberized gasket joint, installing a 36" down drain and FES at the outlet, and replenishing Rock Slope Protection at the outlet. At Location 2 (PM 22.66) the scope of work includes replacing the existing 24" CSP with a new 24" CSP, replacing the existing metal FESs at the inlet and outlet, and grading the outlet ditch. All work will occur with Caltrans existing Right of Way. The purpose of this project is to replace the damaged and failing culverts. The project is needed to extend the service life of SR-49 and maintain motorist safety across these drainages.

• If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County Coroner should be contacted. Pursuant to Public Resources Code Section 5097.98, if the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) which will then notify the Most Likely Descendent (MLD). At that time, the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.

Hazardous Waste

• Caltrans Standard Special Provision 7-1.02K(6)(j)(iii) pertaining to earth material containing lead, shall be included in the contract.

Biology

• If construction will occur during bird nesting season (February 1 through September 30), contact the Environmental Office at least one month prior to the start of construction to schedule a pre-construction bird survey. The pre-con bird survey must be completed within 14 days prior to the start of any construction related activities. Caltrans Standard Special Provision (SSP) 14-6.03A regarding protective radii shall be included in the construction contract. If active migratory bird nests are observed during the pre-construction bird survey, a 100-foot protective buffer shall be established around the nest. For hawks, a 300-foot

buffer shall be established. No personnel, equipment, or construction related activities will be allowed within the protective buffer limits until the young have fledged the nest and until authorized by the Caltrans District 10 Environmental Office.
