The California Department of Transportation (Caltrans) is proposing the State Route 1 (SR 1) Centerline Rumble Strip Project (Project) and is the lead agency under the California Environmental Quality Act (CEQA) and National Environmental Policy Act (NEPA). Caltrans District 4 (Bay Area) has released the Draft Initial Study with Proposed Negative Declaration (IS/ND) for public review and comment.

The Project is located on SR 1 in Sonoma County, California, between Post Mile (PM) 0.0 and PM 58.58. The Project proposes four discontinuous segments of centerline rumble strip and shoulder widening to 6 feet at 50 spot locations.

Caltrans has analyzed the impacts that the proposed Project would have on the environment. The findings of the analysis are presented in the Draft IS/ND which is available for review during a 30-day public review period.
