**Project Title:** Kim Private Floating Dock (Streambed Alteration Agreement EPIMS Notification No. SAC-33107 -R2

**Project Location:** The project is located at the Sacramento River, in unincorporated Sacramento County, State of California; Latitude 38.643900, Longitude -121.564219 (WGS 84 datum, decimal degrees); Assessor's Parcel Number 225-0090-016-0000. The project is located at 4007 Garden Highway, Sacramento 95384.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS Notification Number SAC-33107-R2, pursuant to Section 1602 of the Fish and Game Code to the project Applicant, Beth Ann Kim.

The project is limited the installation of a private boat dock with cover, gangway and landing. The proposed dock and gangway will be manufactured off-site and delivered to the nearest boat ramp. Installation of the dock will require pile driving of four (4) 12-inch steel piles at a length of 40-feet with a barge-mounted pile driver. Pile driving will be completed in one day.

The dock will consist of a W-shape structure, measuring 32-feet by 40-feet with two (2) fingers measuring 4-feet by 24-feet and one (1) finger measuring 8-feet by 40 feet, and a head float measuring 8-feet by 40-feet. In total, the dock will cover approximately 704 square feet. The dock will have an aluminum frame and composite decking with encapsulated floatation.

A 3-foot by 70-foot aluminum gangway will be installed to access the dock, covering an area of approximately 210 square feet. A 3-foot by 4-foot by 1.5-foot concrete landing will be installed on the bank of the Sacramento River to anchor the gangway to shore. The landing will include two (2) 4-inch pipe piles to allow the gangway to rise during flood conditions. Minor impacts to existing rip rap and non-native vegetation are anticipated for the installation of the concrete pad, but native trees and shrubs will not be removed.
