**Project Description:** 

The Gilroy Square project includes subdividing APN 841-070-049, 10.07 acres, into six (6) lots, and Architectural and Site Review to establish the development plan for Phase II of the Regency Center Planned Unit

Development (PUD) and approve development on four (4) of the lots. The proposed project includes two, four-story hotels, a drive-through fast food restaurant, a gas station with convenience store and carwash, a four-story speculative industrial warehouse, and a one-story speculative warehouse building. The warehouse buildings are proposed as future development.

Review and Comment Period: The public review period begins on Friday, January 27, 2023 and ends on Monday, February 27, 2023.
