PROJECT TITLE: The California Wildfire Mitigation Program-Home Hardening Initiative [Categorical Exemption (CE 23-02)]

PROJECT LOCATION: Residential properties within the Kelseyville Rivera. Specific addresses to be served within these project areas are unknown at this time and will be determined as homeowners from within the project area apply to participate in the program.

COUNTY: Lake

DESCRIPTION OF PROJECT: The North Coast Opportunities (NCO) has partnered with California Office of Emergency Services (Cal OES), the California Department of Forestry and Fire Protection (CAL FIRE), and the County of Lake for the Lake County Home Hardening Program. Home hardening addresses the most vulnerable components of your house with building materials and installation techniques that increase resistance to heat, flames, and embers that accompany most wildfires. The program will provide home hardening measures to 500 homes within the Kelseyville Rivera Community Association over a 3-year period, with a goal of completing 25 homes in year one, 100 homes in year two, and 375 homes in year three. Totaling 500 hardened homes over the life of the project. Home Hardening would include defensible Space Measures including but not limited to:

-Removal of dead and dying trees, branches

-Moving auxiliary buildings or structures away from residence

-Replacement of combustible fencing and gates

-Creation of vertical and/or horizontal space

-Removal of any dead and dying debris and fuels

Defensible Space Measures would include, but would not be limited to:

-Recover Roofs with Class A fire resistant materials

-Install metal vents or flashing

-Add metal screens, noncombustible weather stripping, etc.

-Install double pane, tempered windows

-Closing or plugging of holes / bird stopping

-Replace exterior wall coverings with noncombustible material -Install noncombustible skirting on mobile homes


The County of Lake Community Development Department finds that Home Hardening Program is categorically exempt from the requirements of CEQA.
