**PROJECT TITLE:** Residence #8 Rehabilitation - Aunt Sally's

LOCATION: Columbia State Historic Park, Aunt Sally's House COUNTY: Tuolumne

**DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT**: Complete repairs to the historic residence #8, in Columbia State Historic Park to stabilization and preservation this historic resource. Constructed in 1850's residence # 8, currently known today as "Aunt Sally's, needs stabilization and preservation repairs. The scope of work will include repairs to the roof, siding, doors, windows, and lead paint stabilization on both house and garage. Work will:

- Dismantle the existing 24-inch cedar shake roofing and repair any failed rafters or framing components as needed;
- Replace/install skip sheeting with 3/8" plywood, Grace's Ice & Water shield, and a layer of nylon cedar breather;
- Install New Class B fire rated shakes in accordance with current fire codes and complete, As needed, repairs to soffits, flashing, fascias, and damaged rafter tails;
- Install drip edges, half-round steel rain gutters with leaf guards and downspouts to divert water runoff away from the building;
- Replace/repair, as needed, degenerated 7-inch square-edge shiplap siding with "in kind" materials:
- Rehabilitate nine (9) window sashes, casings, stools, aprons and window heads. Reinstall windows with head flashing and flashing tape to repel rainwater;
- Rehabilitate three (3) exterior doors and reinstall doors with head flashing and flashing tape to repel rainwater;
- On the double door garage, repair/ replace rotted boards and framing members;
- On the garage's exterior, remove loose flaky lead-based paint and sand down to next sound layer;
- Encapsulate any remaining lead paint with FIBERLOCK LBC III Industrial Lead Encapsulant primer; and
- Prime and paint all wooden trims, sidings, doors, windows, etc. with 'in-kind" colors to match existing.
