If there are no major comments or requests for a hearing, Caltrans will proceed with the project's design.



#### WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to extend the service life and improve the ride quality of State Route 58 in San Luis Obispo County near the town of Santa Margarita. Caltrans proposes a Rubberized Hot Mix Asphalt overlay within the project limits. Six-foot shoulders, sidewalks, and curb ramps are proposed from I Street to West Pozo Road. Existing asphalt concrete dikes would be upgraded to meet existing standards. Additionally, 10 drainages and 36 roadside sign panels would be replaced, one count station would be installed, and the existing metal beam guardrail would be replaced with the current standard.

WHY THIS PUBLIC NOTICE? Caltrans has studied the effects this project may have on the environment. Our studies show the project will not significantly affect the quality of the environment. The report that explains why is called an Initial Study with Proposed Mitigated Negative Declaration. This notice is to inform you of the preparation of the Initial Study with Proposed Mitigated Negative Declaration and of its availability for you to read and comment on. This notice also offers you an opportunity to request a
