## Letter of Hydrologic Intent

Commercial Development Project Seneca Road and U.S Highway 395 Adelanto, CA May 13, 2021

## Project Location:

The proposed project is located in the City of Adelanto, San Bernardino County, at the corner of Seneca Road and U.S. Highway 395. The project is located in the North ½ of the Northeast ¼ of the Northeast ¼ of Section 21, Township 5 North, Range 5 West, San Bernardino Base and Meridian. The property is currently associated with assessor parcel number 3103-511-05. The site is approximately ±6.5 miles Southwest of the Mojave River.

## Project Description:


The City of Adelanto is located in the High Desert region of San Bernardino County, just north of the San Gabriel Mountains. The approximate 8.3acre site consists of desert land and is void of buildings, structures, or improvements. The proposed project will split the property into approximately five commercial lots (land use subject to change) and provide spinal infrastructures such as rough grading, circulations and access routes, and critical utilities. The planned first development will be approximately ±1.60 acres for a proposed new Quick N' Clean carwash in the southeast corner of the overall site consisting of a 4,961 S.F. car wash, cleaning facilities, parking, and landscape areas.

At time of this letter, detailed site design for the overall development is unknown, however it is anticipated the final development will include commercial developments on all individual parcels with approximate impervious coverage equal to 80%. As public stormwater infrastructure does not appear to be available on-site it is anticipated that stormwater will be privately managed on-site in a variety of water quality and retention facilities. The Mojave River is located approximately 6.5 miles to the northeast and is a listed 303d impaired waterbody. The Mojave River would be the receiving water body in extreme storm conditions, though it is not anticipated that runoff from the project site would reach the River before infiltrating into the surrounding soils. The overall development, and all individual private developments shall be required to comply with applicable sections of the San Bernardino County *Mojave River Watershed Technical Guidance Document for Water Quality Managements Plans* under water quality order No. 2013-0001-DWQ dated April 4, 2016, or the most current version thereof, for stormwater management.


