**PROJECT DESCRIPTION:** Coastal Development Permit (CDP) to construct a three-story, 24,435-square-foot mixeduse building with a two level 33,535-square-foot subterrain parking garage. The project would build 12 residential apartments with roof decks on the upper levels of the building and a residential lobby area and commercial spaces on the ground level. In addition, the project would provide 102 vehicular, 10 motorcycle, and 20 bicycle spots, including both accessible and Electrical Vehicle Charging Stations (EVCS) stalls. The 0.40-acre site is located within the La Jolla Planned District Zone 1 (LJPD-1) and the Coastal (Non-Appealable Area) Overlay Zone within the La Jolla Community Plan area, and Council District 1. **The site is not included on any Government Code listing of hazardous waste sites**.
