- Brief Description of the Project: Agricultural Erosion Control Plan Section 17 Exemption. Track I ECPA (New Vineyard) - Nikolau - Conversion to vineyard of 3.4 gross acres (2.5 net acres) of moderately sloped (17-24%) douglas fir forest (2.9 acres of 42.0 total forest acres converted), non-native annual grassland (<0.3 acres of 3.8 acres converted), and developed area (0.3 acres of 3.1 acres) located within the Dutch Henry Creek watershed consisting of approximately 60-acres (APN 018-050-072; 432 Dutch Canyon Road) located on the east side of Silverado Trail approximately 1.6 miles northeast of the intersection of Silverado Trail and Dutch Henry Creek Road.
- The project site is not located on the lists enumerated under Section 65962.5 of the Government Code, including, but not limited to lists of hazardous waste facilities.

PRELIMINARY DETERMINATION:

The Napa County Director of the Department of Planning, Building and Environmental Services has tentatively determined that the project analyzed in the attached initial study checklist would not have a significant effect on the environment provided mitigation measures are included, and the County intends to adopt a mitigated negative declaration.
