MITIGATED NEGATIVE DECLARATION FOR COUNTY PLANNING FILE PLN220012 MINOR SUBDIVISION 6810 FAIRVIEW ROAD – DATED FEBRUARY 3, 2023 (STATE CLEARINGHOUSE NUMBER: 2023020098)

Dear Mr. Olivas:

The Department of Toxic Substances Control (DTSC) received a Mitigated Negative Declaration (MND) for the County Planning File PLN220012 Minor Subdivision 6810 Fairview Road (Project). The Lead Agency is receiving this notice from DTSC because the Project includes one or more of the following: groundbreaking activities, work in close proximity to a roadway, importation of backfill soil, and/or work on or in close proximity to an agricultural or former agricultural site.

DTSC recommends that the following issues be evaluated in the Hazards and Hazardous Materials section of the MND:

 Refiners in the United States started adding lead compounds to gasoline in the 1920s in order to boost octane levels and improve engine performance. This practice did not officially end until 1992 when lead was banned as a fuel additive in California. Tailpipe emissions from automobiles using leaded gasoline contained lead and resulted in aerially deposited lead (ADL) being deposited in and along roadways throughout the state. ADL-contaminated soils still exist along roadsides and medians and can also be found underneath some existing road surfaces due to past construction activities. Due to the potential for ADL-contaminated soil DTSC, recommends collecting soil samples for lead

analysis prior to performing any intrusive activities for the project described in the MND.

- If any projects initiated as part of the proposed project require the importation of soil to backfill any excavated areas, proper sampling should be conducted to ensure that the imported soil is free of contamination. DTSC recommends the imported materials be characterized according to DTSC's 2001 <u>Information</u> <u>Advisory Clean Imported Fill Material</u>.
- 3. If any sites included as part of the proposed project have been used for agricultural, weed abatement or related activities, proper investigation for organochlorinated pesticides should be discussed in the MND. DTSC recommends the current and former agricultural lands be evaluated in accordance with DTSC's 2008 <u>Interim Guidance for Sampling Agricultural Properties (Third Revision)</u>.
