The subject parcels are located on the northwest corner of South Peach Avenue and American Avenue approximately 0.66 mile southeast of the City limits of the City of Fresno (APNs: 331-110-19 & 23; 331-090-60) (4723, 4591 and 4445 S. Peach Avenue) (Sup. Dist. 4).

Allow the rezone of a 38.86-acre parcel from the existing AL-20 (Limited Agricultural, 20-acre minimum parcel size) Zone District to the M-3 (Heavy Industrial) Zone District and approve a Site Plan Review for a 1,312,000 square feet warehouse/distribution center with related improvements on the subject 38.86-acre parcel and the adjoining 33-acre parcel and a 1.49-acre parcel currently zoned M-3.

Surrounding land uses and setting: Briefly describe the project's surroundings:

The project area has mixed industrial and agricultural uses. Parcels to the east of Peach Avenue, northwest of Golden State Blvd and south of American Avenue are active farmland with single-family homes. The area to the north and the northwest of the project site consists of M-1 and M-3 zoned parcels developed with light and heavy industrial uses.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code Section 21080.3.2.) Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code Section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation. The project site is not located in an area designated as highly or moderately sensitive for archeological resources. Pursuant to Assembly Bill (AB) 52, the project was routed to the Santa Rosa Rancheria Tachi Yokut Tribe, Picayune Rancheria of the Chukchansi Indians, Dumna Wo Wah Tribal Government, and Table Mountain Rancheria offering them an opportunity to consult under Public Resources Code (PRC) Section 21080.3(b) with a 30-day window to formally respond to the County letter. No tribe requested consultation, and Santa Rosa Rancheria Tachi Yokut Tribe responded with no comments on the project. The Mitigation Measure included in the CULTURAL ANALYSIS section of this report will eliminate any potential impact to tribal cultural resources, if discovered on the property.
