## **Project Description:**

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 01/06/2021, by Three Habitat Consulting Storke LLC. The Three Habitat Consulting Storke LLC applied for a cannabis retail dispensary.

## **Project Activities:**

The proposed project will operate a cannabis retail dispensary out of an existing facility located at 290 STORKE RD, SUITE G, GOLETA, CA 93117(-2966) (APN 073-100-030).

The applicant has proposed to use 4,900 sq.ft. of a 13,976 sq.ft. building on a 43,560 sq.ft. lot to operate a cannabis retail dispensary.

No exterior expansion is required.

Interior modifications included light demolition of the flooring and kitchen, new ADA ramp installation, repairs to the roof, new floors and doors installed, improvements with new mechanical and upgrades to electrical. Retail cabinetry, security check-in and security systems were installed. The interior and exterior of the building was painted.
