The proposed, "8141 Van Nuys Boulevard Project," is located at 8141, 8155, 8159 N. Van Nuys Boulevard and 14528-14550 W. Titus Street, Los Angeles CA., 91402. These locations are all located in Reporting District 1994. This "RD" falls within the geographical boundaries of the Los Angeles Police Department's Mission Division. A project of this size could have a minor impact on police services within Mission Division's Community area. The Department is available to advise you on crime prevention features appropriate for the design of the properties in this project. The following report was prepared for the "8141 Van Nuys Boulevard Project" in accordance with Section 15082 of the California Environmental Quality Act (CEQA):

Project Location / Description:

The "8141 Van Nuys Boulevard Project" (APN: 0000-000-000) is located at 8141, 8155 and 8159 N. Van Nuys Boulevard, Mission Hills CA., 91402. The project's additional locations are, 14528 and 14550 Titus Street Los Angeles CA., 91402. These additional addresses are also located in the City of Mission Hills CA.

The proposed project plans to develop the area with an existing 14- story, mixed use building with 194 residential units and 11,088 square feet of retail area. The project also plans to develop a 7-story, mixed use building with 200 residential units and 2,450 square feet of commercial use. Additionally, a 4-level, 498 parking space, parking structure is proposed. A 18,928 square foot warehouse is also in the project plan. These projects are all located in the City of Los Angeles, Mission Hills section of the San Fernando Valley.

Project Distance and Times:

The 8141, 8155 and 8159 N. Van Nuys Boulevard addresses are approximately 1.9 miles at 5 minutes from the Mission Area Community Police Station. The 14528 and the 14550 W. Titus Street addresses are 2.0 miles at 6 minutes from the Mission Area Community Police Station.

These times and distances were calculated from a departure point starting from the Mission Area Community Police Station. These arrival times were also configured utilizing some traffic delays, but estimated times of arrival can vary depending on divisional call load, traffic delays and types of calls.

The Reporting District for the Mission Area Community Police Station is RD 1994. Their phone number is (818) 838-9800.

Divisional Geographics / Demographics:

Mission Area Community Police Station's Geographical Patrol Area is approximately 28.18 square miles and consists of 60 Reporting Districts. The service boundaries for Mission Area are as follows:

To the *West* is Interstate 405-San Diego Freeway and Interstate 5-Golden State Freeway.

To the <u>North</u> is Los Angeles County Border-Angeles National Forest (land delineation only, no streets).

To the <u>East</u> is Los Angeles County Border-Pacoima Canyon (land delineation only, no streets), Los Angeles County Border-Lopez Canyon (land delineation only, no streets), Foothill Boulevard, City of San Fernando Border (land delineation only, no streets), Los Angeles Police Department's Foothill Division Border (land delineation only, no streets), Interstate 5-Golden State Freeway, California 170-Hollywood Freeway, Cantara Street and the Tujunga Wash.

To the **South** is Railroad System-Ventura Subdivision MT-1 and MT-2.

The proposed "8141 Van Nuys Boulevard Project" is located in *RD 1994*. The border for *RD 1994* is as follows:

Reporting District 1994

To the West is the Pacoima Wash.

To the **North** is Roscoe Boulevard.

To the East is Van Nuys Boulevard.

To the <u>South</u> is Lanark Street, Willis Avenue and Railroad System-Ventura Subdivision MT-1 and MT-2.

Mission Division has approximately 291 sworn personnel and 18 civilian support staff. Mission Hills is a culturally diverse community with a residential population of over 201,862. The officer to resident ratio is 1 officer to every 694 residents (694:1) for a 28.18 square mile area. This population amount does not reflect citizens from outside the area visiting local businesses, churches, residences and educational institutions.

Additionally, department wide, the Los Angeles Police Department currently has 9,992 sworn personnel and 3,178 civilian employees. These city police employees cater to a city population of approximately 4,015,940. This population amount is current as of May 21st 2020 (according to LAPDonline.org, 2010-2018 American Community Survey and The US Census). Additionally, this amount does not include non-residents, but only reflects those individuals that responded to the 2010 Census. This population also equates to a resident to officer ratio of 401.9 residents for every 1 officer (401.9:1). 4,015,940 depicts a firm registered value of the population for the City of Los Angeles. However, this number can also be fluid.

The ethnic break down of The City of Los Angeles, according to the 2010-2018 American Community Survey is:

- 48.6% Hispanic / Latino
- 28.47% White (Non-Hispanic)
- 11.49% Asian
- 8.60% Black / African American
- 0.15% Native American
- 0.15% Native Hawaiian / Pacific Islander
- 2.44% Other

Divisional Support and Communication:

There are many specialized support units, divisions and services available to Mission Division within the LAPD (i.e., Air Support, Detectives, K9 and Metro) to support any additional policing needs. These services are available to supplement and complement the division's policing services. In using these available resources, the Los Angeles Police Department can meet the demands for police services for the 8141 Van Nuys Boulevard Project.

Mission Area Community Police Station's emergency response system is directly linked to the Los Angeles Police Department's Communication Dispatch Center. Communication Division has the responsibility to staff the Dispatch Center and respond to telephoned calls for service. This operation is performed on a 24 hour a day, 7 days a week basis. This includes 911 emergency calls (police, fire and medical). Communication Division's main protocol is to manage and dispatch police calls for service in the City of Los Angeles.

Divisional Response Times:

According to the Los Angeles Police Department's Computer Statistics (CompStats) Division, the average police response time to emergency, high priority calls in the Mission Division Area (Code 3 calls) was 3.8 minutes (as of August 29th 2020). This was done with a dispatch median time of 1.6 minutes. The medium high priority response time (Code 2) as of August 29th 2020, was 11.9 minutes. This was done with a dispatch median time of 4.5 minutes. Low priority, non-emergency response times as of August 29th 2020, was 30.7 minutes. These low priority calls had a dispatch median time of 11.4 minutes.

Citywide response times during this same 4 week period were 4.4 minutes for emergency, high priority calls with a dispatch median time of 1.5 minutes. The medium high priority response times were 14.3 minutes with a dispatch time of 4.7 minutes. Low priority response times were 32.9 minutes with a dispatch time of 14.2 minutes.

These response times were taken from the statistics submitted by Mission Division and CompStats for a 4 week period between August 2nd 2020 through August 29th 2020.

During this same 4 week period, Mission Division answered 239 emergency calls for service, 1,106 medium high priority calls and 1,350 low priority calls. Citywide, the Los Angeles Police Department answered 7,283 emergency calls for service, 27,884 medium high priority calls and 30,943 low priority calls. The response times stated are adequate performance times for this police division.






