**DESCRIPTION:** 

The Twain Harte Storm Drain Rehabilitation project will replace 2,900 feet of deteriorated underground storm drain main trunk lines and facilities by inserting slipline pipes of smaller diameter into existing trunklines. The existing storm drain system includes underground pipes ranging from 18 to 42 inches in diameter. These storm drains provide conveyance for stormwater collected from the central portion of the community, including the business area, Twain Harte Elementary School, and the Twain Harte Village shopping center. The water moving through these pipes ultimately discharges into Twain Harte Creek, adjacent to Eproson Park. The project will also incorporate ADA pedestrian infrastructure improvements in the developed urban core of Twain Harte.



Code, § 711.4, subdivision (d); Cal. Code Regs., tit. 14, § 753.5). Without the appropriate fee, statutory or categorical exemption, or a valid No Effect Determination issued by the California Department of Fish and Wildlife (CDFW), the Notice of Determination is not operative, vested, or final, and shall not be accepted by the county clerk.

#### COUNTY DOCUMENTARY HANDLING FEE

The county clerk may charge a documentary handling fee of fifty dollars (\$50) per filing in addition to the environmental filing fee (Fish & G. Code, § 711.4, subd. (e); Cal.
