**PROJECT TITLE:** Wassama Round House Power Pole **LOCATION:** Wassama Round House State Historic Park **COUNTY:** Mariposa

**DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT**: The purpose of this project is to relocate a power pole located in Wassama Round House State Historic Park in order to maintain power supply to a water pump and residence outside of park boundaries and alleviate the need to trim heritage oaks that posed hazards to lines strung via the current pole's location. This will require new trenching to supply power from the new transformer. Work will:

- Excavate a 6-ft. deep x 8-in. diameter hole and place a 30-ft. pole to carry power lines relocated from an adjacent PG&E line;
- Excavate a 40-ft. long x 30-in. deep x 12-in. wide trench from the new pole to an existing campsite pedestal;
- Excavate a 260-ft. long x 30-in. deep x 15-in. wide trench from the new pole to an existing connection pedestal;
- Install one (1) underground pullbox, 300-ft of conduit and electrical wire;
- Backfill the trench with 4-in. of sand around conduits; and
- Fill remaining excavated areas with previously excavated native fill.
