The project site is located on the south side of W. North Ave. between S. Fruit Ave. and S. Walnut Ave., approximately 887 feet west of the city limits of the City of Fresno. (APN: 328-102-09) (1315 W. North Ave.) (Sup. Dist. 1).

Allow a (value added agricultural use and facilities) with the construction of a 2,400 sq. ft. cold storage building and a 300 sq ft. storage building on a 5.0-acre parcel within the AE-20 (Exclusive Agricultural, 20-acre minimum acre parcel size) Zone District.

9. Surrounding land uses and setting: Briefly describe the project's surroundings:

The project site is located in a mainly agricultural area with agricultural land located throughout the region.

Participating California Native American Tribes were notified of the subject application and given the opportunity to enter into consultation with the County of Fresno to address potential cultural resources. Participating California Native American Tribes did not enter into consultation with the County on the project and no concerns were expressed with the project.
